

# Utica Boilers 10 Year Limited Warranty for Residential Cast Iron Steam Boilers

**First Year-Limited Warranty for Residential Steam Boilers:** Utica Boilers warrants that its residential steam boilers are free from defects in material and workmanship for one year from the date of installation. If any parts are found to be defective in manufacture, Utica Boilers will supply a replacement for the defective part(s).

**Second through Tenth Years-Limited Warranty for the Cast Iron Sections of its Residential Steam Boilers:** Utica Boilers warrants that the cast iron section of its residential steam boilers are free from defects in material and workmanship for the second through the tenth years following the date of installation. If any sections are then found to be defective, Utica Boilers will supply a replacement heat exchanger.

This warranty is subject to the condition that the residential steam boiler must have been installed by a heating contractor whose principal occupation is the sale and installation of plumbing, heating and/or air conditioning equipment.

This warranty does not cover.

1. Boilers installed in buildings other than one or two family dwelling units, unless they are buildings with individual boilers for each dwelling unit.
2. Components that are part of the heating system but were not furnished by Utica boilers as a part of the residential steam boiler.
3. The workmanship of any installer of Utica Boilers residential steam boilers. In addition, this warranty does not assume any liability of any nature for unsatisfactory performance caused by improper installation.
4. Any costs for labor for removal and reinstallation of the alleged defective part, transportation to Utica Boilers if necessary, and any other materials necessary to perform the exchange.
5. Improper burner adjustments, control settings, care or maintenance. Information is included in the Installation Instructions, Owner's Information Manual and/or Start-Up,

Service and Maintenance Instructions, and other printed technical material furnished by Utica Boilers with the boiler.

6. Boilers operated with combustion air contaminated externally by chemical vapors, with improper fuel additives, or with water conditions which may have caused unusual deposits in the cast iron sections.

This warranty does not extend to anyone except the first purchaser at retail and only when the boiler is in the original installation site.

**IMPLIED WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE AND MERCHANTABILITY SHALL BE LIMITED TO THE DURATION OF THE EXPRESS WARRANTY. UTICA BOILERS EXPRESSLY DISCLAIMS AND EXCLUDES ANY LIABILITY FOR CONSEQUENTIAL OR INCIDENTAL DAMAGES FOR BREACH OF ANY EXPRESS OR IMPLIED WARRANTY.**

Some states do not allow the exclusion or limitation of incidental or consequential damages, or limitations on how long an implied warranty lasts, so the above limitations and exclusions may not apply to you.

For prompt warranty service, notify the installer who, in turn, will notify the Utica Boilers distributor from whom he purchased the boiler. If this action does not result in warranty service, contact Utica Boilers Customer Service Department, 2201 Dwyer Avenue, Utica, New York 13501 with details in support of the warranty claim. Alleged defective part or parts must be returned through trade channels in accordance with the Utica Boilers procedure currently in force for handling returned goods for the purpose of inspection to determine cause of failure. Utica Boilers will furnish the new part(s) to an authorized Utica Boilers distributor who, in turn, will furnish the part(s) to the heating contractor who installed the boiler.
